PAREX Industries Ltd has provided this declaration to satisfy the provisions of Schedule 1(d) of the Building (Building Product Information Requirements) Regulations 2022.

## Description

The InSinkErator MultiTap Chilled range is a bench top mounted filtered near boiling, chilled & ambient cold and domestic hot water tap, manufactured from DZR brass and incorporates a spring-loaded lever for child safety.

It is suitable for domestic use with mains pressure water supplies. The near boiling and chilled water flow approx. 3 litres per minute while the mixer tap flows approx. 5 litres per minute.

The range is available with either a chrome, brushed steel or matte black finish. Coloured indicators identify hot and cold levers.

## Scope of use

The InSinkErator MultiTap Chilled is intended for use in domestic kitchens. It is designed for a hot and cold water mains pressure supply. The unit is bench-top mounted. The system is compatible with all fittings manufactured to NZS 3501.

## Conditions of use

InSinkErator recommends the MultiTap Chilled be installed by a registered plumber in accordance with the provided instruction manual. This product is intended for domestic use only. It is not recommended for high use applications such as public amenities, schools, sports facilities, factories, or commercial premises etc. This product is cleanable and impervious to moisture – cleaning shall be done in accordance with the manufacturer's cleaning instructions.

## Contributions to compliance

B2.3.1(c): InSinkErator MultiTap Chilled has a durability of at least 5 years when used under normal domestic conditions. Refer to spec sheet for warranty period.

F2.3.1: InSinkErator MultiTap Chilled is constructed from DZR brass and has no harmful concentrations in its construction. It is safe for use with potable water.

G1.3.2: InSinkErator MultiTap Chilled is constructed and finished in such a way as to allow for effective cleaning and avoid harbouring of dirt and germs.

G12.3.2b and c: InSinkErator MultiTap Chilled is installed in such a manner that avoids any likelihood of contamination within the system and water main. InSinkErator MultiTap Chilled uses components that will not contaminate the delivered water.

G12.3.5: InSinkErator MultiTap Chilled provides near boiling, chilled & ambient cold and domestic hot water for drinking, cooking and cleaning.
